All bids must be accompanied by a Bid Security as specified in notice counting from the day of bid opening and must be accompanied by the bid bond authorized from the recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity periods. Bids will be opened in the presence of Bidders' representatives who choose to attend in person at the Office of Bahradashi Rural Municipality, Chakchaki, Jhapa, immediately after the submission deadline as stated on above table.
