Bids received after this deadline will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend in person at the Office of Bahradashi Rural Municipality, Chakchaki, Jhapa immediately after the submission deadline at 13:00 Noon 24th May 2019(10th Jestha, 2076).
- 5. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- 6. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- 7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. Other Related rules and regulation are as per Public Procurement Act 2063 and Public Procurement Regulation 2064.
